Re: Acquisition of IDOX; Equity Commitment

Ladies and Gentlemen:

This letter agreement sets forth the commitment of E. León Jimenes Financial, S.A., a Panamanian corporation (the "Investor"), subject to the terms and conditions herein, to provide a financial commitment to Long Path Co-Investment Fund #6, LP¹, a Delaware limited partnership (the "Fund") to allow Long Path Partners, LP (the "Investment Manager" and collectively with the Investor and the Fund, the "Parties") to acquire a participation in IDOX.

- 1. <u>Commitment</u>. The Investor hereby commits an aggregate amount equal to US\$80,000,000 to the Fund (the "Commitment") for the purpose of the Investment Manager executing certain documentation with respect to a proposed investment in IDOX for the Fund. Subject to the Investor's completion of its confirmatory due diligence, the Investor will execute the governing documents for the Fund and will be subject to the legal rights and obligations set forth therein.
- 2. <u>Termination</u>. The obligation of the Investor to fund the Commitment will terminate automatically if the Investor does not execute the governing documents of the Fund within thirty (30) calendar days from the date of this letter agreement.
- 3. <u>Parties in Interest; Third Party Beneficiaries</u>. This letter agreement is for the sole benefit of Parties and their respective successors and permitted assigns. Nothing in this letter agreement, express or implied, is intended to or shall confer upon any person other than the Parties any legal or equitable right, benefit or remedy of any nature whatsoever, under or by reason of this letter agreement.
- 4. <u>No Assignment</u>. The Commitment evidenced by this letter shall not be assignable by Investor without Investment Manager's prior written consent.

5. <u>Miscellaneous</u>. The captions contained in this letter agreement are for reference purposes only, and shall not affect in any way the meaning or interpretation hereof. References in this letter agreement to the neuter gender ("it") shall include the masculine or feminine gender as the context requires. This letter agreement constitutes the entire agreement and supersedes all prior written and oral agreements and understandings between the Parties with respect to the subject matter hereof. This letter agreement may be signed in separate counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument. Regardless of the place of execution, this letter agreement shall be governed by and construed in accordance with the internal laws of the State of Delaware, and the obligations, rights and remedies of the parties hereunder shall be determined in accordance with such laws.
