

DEED OF AMENDMENT TO SHARE PURCHASE AGREEMENT

THIS DEED is made on 15 January 2026

BETWEEN:

- 1) **Long Path Smaller Companies Master Fund, Ltd**, an exempted company incorporated under the laws of the Cayman Islands whose registered office is at Walkers Corporate Limited, 190 Elgin Avenue, George Town, Grand Cayman KY1-9008, Cayman Islands (the “Shareholder”);
- 2) **Frankel US Holdco, LP**, a Delaware limited partnership whose registered office is at Corporation Service Company, 251 Little Falls Drive, Wilmington, New Castle County, Delaware 19808 (“US Holdco”);
- 3) **Frankel UK Holdco Limited**, a private limited company incorporated under the laws of England and Wales, whose registered office address is at Suite 1, 7th Floor 50 Broadway, London, SW1H 0DB (the “UK Holdco”);
- 4) **Frankel UK Midco 1 Limited**, a private limited company incorporated under the laws of England and Wales, whose registered office address is at Suite 1, 7th Floor 50 Broadway, London, SW1H 0DB (the “Midco 1”);
- 5) **Frankel UK Midco 2 Limited**, a private limited company incorporated under the laws of England and Wales, whose registered office address is at Suite 1, 7th Floor 50 Broadway, London, SW1H 0DB (the “Midco 2”); and
- 6) **Frankel UK Bidco Limited**, a private limited company incorporated under the laws of England and Wales, whose registered office address is at Suite 1, 7th Floor 50 Broadway, London, SW1H 0DB (the “Bidco”),

(each a “Party” and together the “Parties”).

INTRODUCTION

- (A) The Parties entered into a sale and purchase agreement on 28 October 2025 relating to the contribution of Shares by the Shareholder to Bidco (the “Original SPA”). The Parties subsequently agreed to amend the Original SPA by way of a deed of amendment entered into on 5 January 2026 (the “Amended SPA”).
- (B) The Amended SPA provided that, as the final fund valuation was yet to be completed, there may be a requirement to further amend the Amended SPA.
- (B) The Parties now so wish to amend the Original SPA and the Amended SPA in accordance with and upon the terms set out in this Deed. Clause 8.3 of the Original SPA provides that any amendment to the Original SPA must be in writing and signed by all the parties to the Original SPA.

THIS DEED WITNESSES that:

1 INTERPRETATION

- 1.1 In this Deed all capitalized terms used but not otherwise defined in this Deed shall have the meaning given to them in the Original SPA.
- 1.2 Clauses 1.2 and 1.3 of the Original SPA shall apply for the purposes of this Deed with references to “Agreement” being substituted by “Deed” where appropriate.

2 VARIATION TO THE AMENDED SPA

- 2.1 As a result of the annual election process by investors in the Shareholders, the parties hereby agree that from the date hereof the definition of “Shares” shall be deleted in its entirety and replaced with the following:

“Shares” means 28,748,136 ordinary shares of GBP 0.01 in the capital of the Target;

- 2.2 Save as expressly amended by this Deed, the terms of the Original SPA shall continue in full force and effect.

3 APPLICATION OF CLAUSES TO THIS DEED

- 3.1 The provisions of clauses 7 to 10 of the Original SPA shall apply for the purposes of this Deed with references to “Agreement” being substituted by “Deed” where appropriate.
